- b. Rose Cottage, Rose Mount. Damage to sandstone wall. WBC are aware of the damage. We await the outcome of the planning process.
- c. 3 South Bank roof works. Actual materials used needs to be checked. **Action DW**
- d. Local Listing. Process appears to be in chaos with several of our submissions rejected. **Action AC** to write to Mandy Lewis to register our concerns.
- e. Ashton House. Looks like this might go to auction. (The boundary wall is on our Local Listing list)
- f. 1-3 Shrewsbury Road. We have written to Christian Hercules stating that our first priority is that the properties should be kept and refurbished. Regarding our own internal processes, whilst we should continue to engage with developers, we need to make sure DW is aware of any such meetings.
- g. Riverhill some interest from the owners has come in the form of a request for history of the property and its past inhabitants.

- i. Design awards Planning group are to assess any submissions for awards at AGM.
